Instructions for Verification

Attached is a Verification Worksheet which must be completed, signed and returned to the Financial Aid Office along with all required documents as indicated on the verification worksheet.

→ The most efficient way to verify income is by using the **IRS Data Retrieval Tool (DRT)** within your FAFSA application. If the Data Retrieval Tool was used successfully when completing the fafsa, the **Verification Worksheet** is all that is required.

If you, or your parents, did not, or could not use the DRT when you filed the FAFSA, you are required to submit signed copies of 2019 Federal Tax Returns and copies of all W-2 forms and/or 1099 forms or a 2019 Tax Return Transcript obtained from IRS.gov. If you, or your parents, filed an amended tax return for 2019, you must also provide a signed copy of the 2019 IRS form 1040X that was filed with the IRS.

→ If the student's parent or step-parent did not file, or is not required to file a 2019 Federal Tax Return, they must submit a 2019 **IRS Verification of Non-filing letter** from the IRS. This letter is required proof that the IRS has no record of a filed tax form 1040 for the 2019 tax year. The Verification of Non-filing letter is a requirement for all parents and step-parents who did not file a federal tax return. Also required from the Non-filer are copies of all 2019 W-2 and/or 1099 forms. **A separate letter must be received for each parent/step-parent living in the household.**

If parent/step-parent was not employed in 2019 and had no income, an IRS Verification of Non-filing letter is still required for each parent/step-parent living in household.

To obtain the Verification of Non-filing letter, go to www.irs.gov (click on "Get Your Tax Record"), or call 1-800-908-9946 or from the IRS site, print a 4506T form. Complete #1-5, check box 7, make sure 12/31/2019 is on line 9, sign and mail to appropriate address as listed on the form.

Nontax filers unable to obtain the Verification of Non-filing: - Independent students, and parents of dependent students who did not file and are not required to file an income tax return for the 2019 tax year may provide a written, dated, signed statement certifying that the individual has made a good-faith effort to obtain the required non-filing document from the IRS or other relevant tax authority and was unable to obtain the required documentation. It must also state that the individual did not and will not file a 2019 federal tax return and list sources of any income earned from work by the individual. In addition to the signed statement, copies of IRS Forms W-2, 1099 forms or an equivalent document, for each source of 2019 employment income received by the individual is required.

A separate letter must be received for each parent/step-parent living in the household.

Note: A dependent student who is a nontax filer is excluded from the verification requirement to provide confirmation of the dependent student's non-filing status from the IRS or other relevant tax authority.
